1. Context

Tunisia is currently engaged in the implementation of the national health policy for 2030, centered on the constitutional right to health. Considered as the culmination of a long work of societal dialogue, spread over 10 years, with a large-scale participatory approach, the national health policy was adopted on April 07, 2021, to be implemented on the basis of a synergistic and dynamic approach. The 2023-2025 three-year development plan, currently being validated, constitutes part of the operationalization of the national health policy in the devoted period.

The implementation of this plan enables to draw up strategic objectives centered on the citizen, by improving health coverage and health services in order to ensure available, accessible and quality health services. Promoting research and innovation in the medical, biomedical and pharmaceutical fields is highly important to enhance global competitiveness and society-oriented research, all in a logic of strengthening leadership and governance of the health system.

It is in this context marked by a strong commitment of our country to achieve these objectives that the Ministry of Health organizes the panel “Investing in health, perspectives and challenges” in the side events of the 8th edition of the Tokyo International Conference on Development in Africa (TICAD8), with the participation of official representatives of Japan and Africa and innovative structures in the pharmaceutical industry sector, health services, distance training. This event is an opportunity to present and share African success stories as well as African and Japanese experiences within the framework of tripartite exchange.

- Present Tunisia's competitive advantages in the health sector, particularly in the following areas: the pharmaceutical industry, medical care services, training.
- Expose opportunities for investment and partnership with Japan and African countries in the various fields of health.
